Subject: Report on looting and damage of my properties at my residential house. West District, Manipur

Sir,

With due respect and honour, I am to report that I am a resident of Lamphelpat pursuing my studies at Imphal.

That, due to the communal clash that broke out from May 3, 2023, I had abandoned my rented house located inside the official Quarter Type-V/G-VIII, Lamphelpat, Imphal West District, Manipur, on 04-05-2023 and took shelter at an MLA Quarter and then shifted to CRPF Camp, Lamphel, the following day. On 08-05-2023, self along with family members were evacuated to Kangpokpi.

That, I had received information from neighbours that my rented house, mentioned above, was broke open and all my properties (both moveable and immovable properties) were damaged and looted by unknown miscreants on the 4<sup>th</sup> May, 2023 at around 4:00 p.m.

List of properties damaged and looted are as below:

- 1. Almirah (2 in nos.) worth Rs. 60,000/-.
- 2. Wooden Bed (3 in nos.) worth Rs. 90,000/-.
- 3. Gas Set with 2 cylinders worth Rs. 15,000/-.
- 4. Furniture Set worth Rs. 50,000/-.
- 5. Books worth Rs. 10,000/-.
- 6. Household utensils worth Rs. 50,000/-.
- 7. Water Storage Tank (Sintex) 2 in nos. worth Rs. 6,000/-.
- 8. Washing Machine worth Rs. 20,000/-.
- 9. Luggage and other accessories worth Rs. 20,000/-.
- 10. Clothes and other wearing garments worth Rs. 50,000/-.
- 11. 2-Wheeler Fascino bearing R/No. MN01AJ3724, Engine No. E3Y4E0175053 worth Rs. 1,20,000/-, owned by one Mr. Khamsuanpao.
- 12. 2-Wheeler Activa-125 BS6 (Rebel red/maroon in colour) bearing R/No. MN06SF0083, owned by one Mr. Thanggoulen Doungel, worth Rs. 1,20,000/-.

Grand total - Rs. 5,91,000/-.

It is, therefore, requested to take up necessary legal action against the said unknown miscreants and to retrieve or recover my properties. Cause of delay in reporting the incident is due to my displacement and the prevailing law and order situation.
