With due respect and humble submission, I would like to report that I, Emanuel Lalremsiem, a driver of RIMS Imphal, resided with my family in RIMS Quarter bearing Type III H.No.32 Lamphelpat, Imphal west, Manipur (Under Lamphel police station Pin- 795004), that due to communal clash that broke out from 3rd May, 2023, I abandoned my quarter.

During our absence, some of the locality inform us that our RIMS Quarter bearing Quarter No. Type III H.No.32 Lamphel, Imphal west, Manipur, was forcefully broken in by unknown miscreants and house hold goods were stolen on 27th July 2023 (Evening). The approximate value of our household goods is about Rs.25 lakhs and our vehicle (Bolero) registration No. MNO1AK 9832, Model - Mahindra Maxi Cab, Colour - Diamond White, Chassis No. MA1XK2WJ5E28385, Engine No. - WJJ6D45154 was also stolen from my garage.

In regards, I humbly request you to register a case and take necessary legal action as per law. Cause of delay in reporting is due to my displacement.
