Subject: Report regarding looting and vandation or rented house by unknown miscreants.

Sir,

With due respect, I would like to request your kind authority for taking necessary action regarding the above mentioned subject.

That, due to the prevailing communal violence that broke out from 03-05-2023, I had abandoned my rented house, owned by one P. Vaiphei, located at Sangaiprou near FCI Godown Imphal West District, PS – Lamphel, since 04-05-2023 and now taking refuge at Churachandpur.

That, on 4<sup>th</sup> May, 2023, I came to learn from my neighbours that on the same day at around 4:00 p.m., my rented house was attacked, broke opened and all my properties (enclosed herewith) were looted and vandalized by the unknown miscreants. All my household properties which were vandalized or stolen by the unknown miscreants were worth Rs. 6,68,370 (approx.).

It is, therefore, requested to kindly take up necessary legal action against the unknown miscreants and help recover my stolen properties.

Cause of delay in reporting on time is due to my displacement and lack of awareness of law.

List of properties stolen or vandalized is enclosed herewith for reference.
