That, on 20-07-2023, I received information from neighborhood that all my properties inside my government quarter were either looted or vandalized by unknown miscreants on 10th May, 2023 at around 2:00 p.m. and my quarter having been occupied by unknown persons without my knowledge and

It is, therefore, requested to take up necessary legal action against the said unknown miscreants. Cause of delay in reporting the incident is due to my displacement and the prevailing law and order
