Subject: Report regarding looting, vandalism and by miscreants.

Sir,

Imphal West District, We With due respect, I would like to request your kind authority for taking necessary action regarding the above mentioned subject.

That, due to the prevailing communal violence that broke out from 03-05-2023, I had abandoned my house located at MS Zoveng, National Game Village, Langol, Imphal West District, PS - Lamphel, since

That, on 4th May, 2023, I came to learn from my neighbours that on the same day at around 4:00 p.m., my house was attacked, broke opened and all my properties (mentioned below) were looted and vandalized including my Jamabandi document bearing the name T. Khamgin Ingkhol (1996), Khopuibung Lourup, and my house gutted/burnt down by the unknown miscreants. All my household properties which were vandalized, stolen away and burnt down by the unknown miscreants were worth Rs. 16,70,000 (approx.).

It is, therefore, requested to kindly take up necessary legal action against the unknown miscreants and help recover my stolen properties.
