Sir,


With due respect, I would like to inform you that on 4<sup>th</sup> May 2023 at around 9:00 pm some valley-based organisations suspected to be volunteers of Arambai Tenggol, Kangleipak Kanba Lup (KKL), Meitei Leepun, broke into my residential quarter at National Games Village, B-404, Zone-2 and looted all my household properties worth approximately around 55(fifty five lakhs) only, which includes very important educational documents of my children, gold ornaments and a sum of Rs.1,25,000/- (one lakh twenty five thousand) only in cash which was kept inside the Godrej(almirah)

I therefore request you to take up necessary legal action regarding the incident.


