With reference to the above cited subject I have the honour to report to you as follows:

- 1. That I, Personal No.M/5025963M, Rank-RFN/NA.Shri. Ngamsanglien Zou of 13 Assam Rifles. Presently posted at Sehlon Battalion Head Quarter. Aged about 28 years S/o T Langchinkhup Zou Belonging to the Zou Tribe / Community, a schedule Tribe recognized under the constitution of India, by virtue of which I am being entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989, and that I am a permanent Resident of National Game Village Imphal-West, Manipur. P.O&P.S., Lamphel.
- 2. That, due to the ethnic violence in the state of Manipur, at about 7:30 am on the 4<sup>rd</sup> May 2023, my family members in order to save their lives left behind our house along with all our household items and took shelter at the nearby CRPF camp. and in the process they have looted then burnt down my house including all our household items and my Two Wheeler (Fascino) Bearing Reg.No.MNO6SB5702, Engine No. E3Y4E0045034, Chassis No. ME1SED195H0027104.
- 3. That, it may be reported here that the above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated to be Rs. 25,00,000/- (Rupees Twenty Five Lakhs) only.
- 4. Fortunately,my family managed to escaped from the criminals, and now currently taking refuge at Simveng Village Churachandpur.
- 5. That, I am filing this information lately because there is a great danger to my life and due to which I was at different places to save my life and now I am able to restore my health and settled at The above mentioned place. And thus, I am filing the report lately today.

In the given circumstances, I humbly pray you kindly register an FIR/ZERO FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged.
