2. That 04<sup>th</sup> May, on 2023, 11am huge contingent of Armed Radical Meitei/Meiteis, Arambai Tenggol and Meitei Leepun attack our Village and in the process looted/vandalized/burnt our house and properties.

3. That the above said Criminals with their in humane activities have caused me grave mental agony. Notwithstanding the fact that, their unruly activities have made me loss enormous wealth estimated to be Rs.6 lakhs only.

4. Fortunately, me and my family narrowly escaped from these criminals who even tried to kill us. Henceforth, we are taking refuge at Twinom Relief Centre, Churachandpur District.

I, therefore, request you to register on FIR and bring justice.
