I am to state that as marauding Meitiei mob leb by :Arambai Tenggol" and "Meitei Leepun" went on rampage in the morning of 4th May 2023 selectively targeting Kuki-Zo community and burning their houses in Langol area, i had to flee for life along with my family members withour picking up even our bare necessities and took shelter at CRPF Camp, Lamphel. As Central Security Forces are said to have arrived after sometime our locality was saved from being destroyed/burnt by the mob although some houses in neighbouring localities were burnt down on that very day.

And since I was hoping for restoration of normalcy soon with Central Security forces in placeand hence refrained from registering any FIR earlier.

But situation turned for the worse later on and according to reliable sources our house located at Hill Side Colony, Opp.G-Secor, LHC Langol, PO&PS-Lamphel, Imphal West was vandalized by miscreantss on 2nd August, 2023 at around 4:00 pm. The said miscreants are said to have broke open locks and looted all our belonging-which consisted of 3 sofa sets, 6 wooden beds with mattress, bedspreads, blankets, 4 dressing tables with cosmetic products, 4 wooden bed boxes, 3 steel almirahs with our dresses-(formal and traditional), jewellery items, inverter with dry battery set, 3 geysers, rooftop solar water heater, Aqua brand desalination plant, dinning table with 6 chairs, 2 washing machines (Whirpool & 1 Samsung), 1 refrigerator, 2 smart TVs (32"&55"), 2laptop computers, 1 Desktop computer set with UPS, computer table and 2 priners,1 Inkjet & 1 Laser), Cloths stacked in 4 built-in-wardrobes, jewelleries, 5 LPG cyclinder, 2 gas burners, 1 Induction cooker, microwave oven, mixer-grinder, utinsils and pots of various sizes, 3 wooden racks, mazchine tools(i.e 1 angle grinder, 1 power drill, 1 circular saw), elesctrical tool set, 1 table fan, 11 ceiling fans, car wash machine, submersible pump, Texwell heavy duty pump, Crompton 1 HP pump, 6 water tanks of 1000 liters capacity each and other miscellaneous items vakued at Rs. 20,00,000/- (Rujpees Twenty las). Our 3 -storeyed building valuednat Rs. 1,80,00,000/- (Rupees one crore and eighty lacs) was completely vandalized ccausing major damage to the structure. The total value of Household items looted and properties damaged amounts of Rs. 2,00,00,000/- (Rupees Two crores)

I would, therefore, request you to kindly register ZERO FIR against the said miscreants since regular FIR could not be filed at the designated Police Station because of safety and security reasons.
