**Subject: Report on the crimes of looting, vandalism and burning of properties**

Sir,

I am to bring to your kind notice that I am a Scheduled Tribe (Kuki/Zo) and a resident  
of National Game Village Zone III C-12.

That, on the July 14<sup>th</sup>, 2023 at noon, my above said residence "Owned/Rented"  
was attacked, destroyed, looted and burned by a Group of Meitei/Meiteis radicals.

These criminals broke/open my gate(s), destroyed and looted every valuable property from  
my residence and premises worth Rupees 515,000 (Approx.) and they burnt down  
all the remainings.

While carrying out their said criminals activities; the said Meitei radical groups were  
shouting anti-tribal slogans.

I, therefore, request you to kindly take strong actions against the perpetrators by registering  
an **FIR/Zero FIR** under relevant sections of Law.
