- 3. That the above said Criminals with their in humane activities have caused me grave mental agony. Notwithstanding the fact that, their unruly activities have made me loss enormous wealth estimated to be Rs. 60 lakhs only.
- 4. Fortunately, me and my family narrowly escaped from these criminals who even tried to kill us. Henceforth, we are taking refuge at Vajing Relief Camp, Churachandpur District.
- I, therefore, request you to register on FIR and bring justice.
