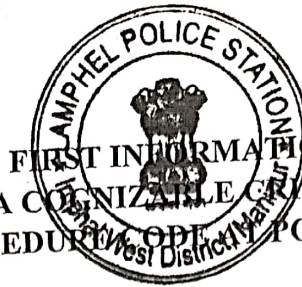

With reference to the above cited Subject, I have the honor to report to you as below:

1. That, I **Vahcy Khongsai, Aged 32 S/o Helun Khongsai** belongs to KUKI Community, a Schedule Tribe recognized under the Constitution of India, by which I am entitled for protection under the ST/SC (Prevention of Atrocities) Act, 1989. Whereby, I had stay at rent at Khongsai Veng, P.S Lamphel, District Imphal East.

2. That, on 4<sup>th</sup> May 2023, 2pm huge contingent of Armed Radical Meitei/Meiteis, Arambai Tenggol and Meitei Leepun attack our rent and in the process looted/vandalized/burnt our rent house and properties.

3. That the above said Criminals with their in humane activities have caused me grave mental agony. Notwithstanding the fact that, their unruly activities have made me loss enormous wealth estimated to be Rs. 60 lakhs only.

4. Fortunately, me and my family narrowly escaped from these criminals who even tried to kill us. Henceforth, we are taking refuge at Vajing Relief Camp, Churachandpur District.

I, therefore, request you to register on FIR and bring justice.
