1. That, I **Ngamkhotang Haokip, Aged 34 H/o Nengkhonei Haokip** belongs to KUKI Community, a Schedule Tribe recognized under the Constitution of India, by which I am entitled for protection under the ST/SC (Prevention of Atrocities) Act, 1989. Whereby, I had stayed at **rent at Langol Game Village, Zone-2 (Punshi Khul leikai) P.S Lamphel, Imphal West District.**
 2. That, on 4th May 2023 at 7am, huge contingent of Armed Radical Meitei/Meiteis, Arambai Tenggol and Meitei Leepun attack my Rent and in the process looted/vandalized/ our properties.
 3. That the above said Criminals with their in humane activities have caused me grave mental agony. Notwithstanding the fact that, their unruly activities have made me loss enormous wealth estimated to be Rs. 11 lakhs only.
 4. Fortunately, me and my family narrowly escaped from these criminals who even tried to kill us. Henceforth, we are taking refuge at Songja Khopi, Churachandpur District.
- I, therefore, request you to register on FIR and bring justice.
