Subject – Report on crimes of vandalism, looting, criminal intimidation, unlawful displacement and discrimination of Scheduled Tribes.

Dear Sir,

With reference to the above cited subject, I have the honour to report to you as follows:

That, I am a Scheduled Tribe belonging to the **Paite Tribe**, which is a recognized Tribe under the Constitution of India, by virtue of which I am being entitled to the protection under **The SC/ST (Prevention of Atrocities) Act, 1989**.

That, due to the prevailing ethnic crisis in and around Imphal, I along with my family left our rented house owned by Shri. Vungzagin Valte, MLA Thanlon A/C, located at Laimanai, Paite veng, P.O. / P.S.- Lamphel, District- Imphal West, it has come to our knowledge that our deserted house was attacked, destroyed and looted by a Group of radical Meeitei/Meiteis suspected to be members of Arambai Tengol and Meetei Leepun on the **4th of May, 2023** at around **1:30 PM**.

The criminals broke open my door, destroyed and looted every valuable property from my house/ premise's worth about **Rs. 12,00,000/- (Rupees Twelve Lakhs)** only.

That, it may be reported here that the miscreants were shouting slogans like- **"KANGLEIPAK YAIPHARE"**; **"KUKI HATLO"**; **"HAO HATLO"**; etc. while they were carrying out their criminal activities. It seems to me that all these has taken place at the instance of the Manipur State Government as the perpetrators openly claimed and shouted that nobody would stop them, even the police because everyone, including top officials of the Manipur Government are patronizing them and that that no harm could be done to them.
