I am to bring to your kind notice that I am a Scheduled Tribe (Kuki/Zo) and a resident of

LAMBOL... GAMES... VILLAGE... IMPHAL... WEST... Quarter no. B/ 76.
Zone-IV

That, on the 4th May, 2023 at 8:30 a.m./p.m. my above said residence
(Owned/Rented) was attacked, destroyed, looted and burned by a Group of Meeitei/Meitei
radicals.

These criminals broke/open my gate(s), destroyed and looted every valuable property
from my "Owned / Rental" House, and premises worth Rupees *forty five lakhs* (Approx.)
and they burnt down all the remaining things. *thirty two thousands & four hundred*
only.

That, while carrying out their above said criminal activities, the said Meitei radical groups
were shouting anti-tribal slogans like- "HAO HATLO", "KUKI HATLO", "KANGLEIPAK
YAI PHARE", etc. Hence, the same can be taken as an insult on me and my family for being a
tribal.

I, therefore, request you to kindly take strong actions against the perpetrators by
registering an FIR/ Zero FIR under relevant sections of the statutes of our country.
