Dear Sir,

With reference to the above cited subject, I have the honour to report to you as follows:

That, I am a Scheduled Tribe belonging to the *Any Kuki Tribe*, which is a recognized Tribe under the Constitution of India, by virtue of which I am being entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989.

That, I am a constable (no.1801404) serving under Manipur Police, whilst, waiting for the Quarter's allotment for me and my family, we stayed at my uncle's place (mother's younger brother) along with his family only for a time being, located at *Qtr. No. A/39*, *Type-II*, *Langol Housing Complex*, *P.O. & P.S.- Lamphelpat*, District-Imphal West.

That, due to the ethnic crisis in and around Imphal Valley, we deserted the said Quarter on the 4th of May,2023 at around 6:30 AM it has come to our knowledge that our deserted house was attacked and looted by a Group of radical Meeitei/Meiteis suspected to be members of Arambai Tenggol and Meitei Leepun on the 4th of May, 2023 at around 4:30 PM.

The criminals broke open my door, destroyed and looted every valuable property from the said Quarter, and in particular, I and my family's personal properties (excluding my Uncle's Properties) is estimated to be worth about Rs. 33,50,700/- (Rupees Thirty-Three Lakhs Fifty Thousand Seven Hundred) only including my Two-Wheeler, Bajaj Avenger 220CC bearing Regn. No. MN01 AD 5748, Black in Colour.

That, it may be reported here that the miscreants were shouting slogans like-"KANGLEIPAK YAIPHARE"; "KUKI HATLO"; "HAO HATLO"; etc. while they were carrying out their criminal activities.

That, I am filing this report lately as I was in different remote areas, therefore, I humbly pray you to kindly register a **ZERO FIR**, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged. Thus, I am filing the report lately today.
