Respected Sir,

With reference to the above cited subject I have the honour to report to you as follows:

1. That, I Lalengmoi, aged about 54 years, W/o Hmanglienkhun Belonging to the Meitei Tribe / Community, a schedule Tribe recognized under the constitution of India, by virtue of which I am being entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989, and that I am a resident of Langthungching, Shija Lamkhai, P.O & P.S., Lamphel, District- Imphal West.
2. That, at about 8:30 am on the 15<sup>th</sup> of May, 2023, due to the arson and attack by radicals group suspected to be members of the Arambai Tengol and Meitei Leepun along with Meitei Mob in the Imphal Vally against the Kuki-Zo Community, I, along with my family have to run for our lives leaving behind all our household items, and in the process, they have looted my Rented house at Langthungching Shija lamkhai along with my two wheeler.
3. That, it may be reported here that the above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated to be Rs.7,90,000/- (Rupees Seven Lakhs Ninety Thousand) only.
4. Fortunately, me and my family managed to escaped from Imphal Valley and took shelter at Mumbai Maharastra, and eventually Came back to our native village at Saidan Village Churachandpur Manipur.

5. That, I am filing this information lately because there is a great danger to my life and due to which I was at different places to save my life and now I am able to restore my health and settled at Saidan Village Churachandpur. And thus, I am filing the report lately today.

In the given circumstances, I humbly pray you kindly register a FIR/ZERO FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged.
