Sir,

With reference to the above cited subject I have the honour to report to you as follows:

- 1. That I Shotil Khongsai aged about 53 years S/o (L) Tilkholet Khongsai Belonging to the Any-Kuki Tribe / Community, a schedule Tribe recognized under the constitution of India, by virtue of which I am being entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989, and that I am a Permanent Resident National Game Village(Imanuel Colony) Imphal-West District Manipur. P.O. &P.S., Lamphel.
- 2. That at about 8 am on the 4th May 2023, due to the ethnic violence in the state I and my Family have to run for our lives leaving behind our house, along with all our belongings. and in the process ,some unknown miscreants Suspected to be a members of Arambai Tengol and Meitei Leepun have looted, vandalised then burnt down our house including all our household items and belongings.
- 3. That, it may be reported here that the above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated to be Rs.65,79,000 (Rupees Sixty Five Lakhs Seventy nine thousand) only
- 4. Fortunately, I managed to escape from the Violence, and took refuge at Aizawl Mizoram.
- 5. That, I am filing this information lately because there is a great danger to my life and due to which I was at different places to save my life and now I am able to restore my health and settled at Molnom ECA Relief Camp Churachandpur. And thus, I am filing the report lately today.

In the given circumstances, I humbly pray you kindly register an FIR/ ZERO FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged.
