Subject – Report on crimes of vandalism, looting, criminal intimidation, unlawful displacement and discrimination of Scheduled Tribes.

Dear Sir,

With reference to the above cited subject, I have the honour to report to you as follows:

That, I am a Scheduled Tribe belonging to the **Hmar Tribe**, which is a recognized Tribe under the Constitution of India, by virtue of which I am being entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989.

That, due to the prevailing ethnic crisis in and around Imphal, I along with my family left our resident quarter located at D-122, Zone-I, National Game Village, Langol, **P.O. & P.S.- Lamphelpat**, District- Imphal West on the **4<sup>th</sup> of May, 2023** at around **7.00 AM**, where, we took shelter at Central Reserve Police Force (CRPF) Camp, Lamphel and since we only escaped with few of our belongings, the CRPF Jawans escorted us to our quarters to take the necessary provisions and on making an entry to my quarter, I came to realized that my quarter has been vandalized and looted by the Meitei/Meitei miscreants suspected to be members of Arambai Tenggol and Meitei Leepun on the **7<sup>th</sup> of May, 2023** at around **11:30 AM**.

The criminals broke open my door, destroyed and looted every valuable property from my quarter / premise's worth about **Rs. 65,80,000/- (Rupees Sixty-Five Eighty Thousand)** only. I also want to highlight the fact that they also torched my Two-Wheeler, Honda Activa 4G bearing **Regn. No. MN02 A 9541** which was parked on the side of the road between Zone-IV (Langol) and CRPF Camp (above-mentioned), on the **4<sup>th</sup> of May, 2023** itself at around **12:30PM**.

That, it may be reported here that the miscreants were shouting slogans like- "**KANGLEIPAK YAIPHARE**"; "**KUKI HATLO**"; "**HAO HATLO**"; etc. while they were carrying out their criminal activities.

That, I am filing this information lately because there is a great danger to my life and due to which I was at different places to save my life and now I am able to restore my health and I humbly pray you to kindly register a **ZERO FIR**, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged. Thus, I am filing the report lately today.
