With reference to the above cited subject, I have the honour to report to you as follows:

That, I am a Scheduled Tribe belonging to the Vaiphei Tribe, which is a recognized Tribe under the Constitution of India, by virtue of which I am being entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989.

That, due to the prevailing ethnic crisis in and around Imphal, I along with my family left our residential quarter located at D-47, Type III, Langol Housing Complex, P.O. & PS.- Lamphelpat, District- Imphal West, it has come to our knowledge that our deserted house was attacked, destroyed and looted by a Group of radical Meeitei/Meiteis suspected to be members of Arambai Tengol and Meetei Leepun on the 4th of May, 2023 at around 10.00 AM.

The criminals broke open my door, destroyed and looted every valuable property from my house/ premise's worth about Rs. 15,09,700/- (Rupees Fifteen Lakhs Nine Thousand Seven

That, it may be reported here that the miscreants were shouting slogans like-"KANGLEIPAK YAIPHARE"; "KUKI HATLO"; "HAO HATLO"; etc. while they were carrying out their criminal activities. It seems to me that all these has taken place at the instance of the Manipur State Government as the perpetrators openly claimed and shouted that nobody would stop them, even the police because everyone, including top officials of the Manipur Government are patronizing them and that that no harm

That, I am filing this information lately because there is a great danger to my life and due to which I was at different places to save my life and now I am able to restore my health and I humbly pray you to kindly register a ZERO FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged. Thus, I am filing the report lately today.
