

Subject: Report regarding looting of properties from my government quarter by unknown miscreants.

Sir,

With due respect, I would like to request your kind authority for taking necessary action regarding the above mentioned subject.

That, I, Ningngaihmang, aged about 59 years W/o (L) L.Guite, working as Assistant Nursing Superintendent at RIMS Hospital, belonging to Paite Tribe, a Scheduled Tribe under the Constitution of India, by virtue of which I am being entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989.

That, I would like to inform and register a cognizable offence committed against me and my family at the Government allotted quarter Type III, CP No. 1, Lamphelpat, Imphal West, Imphal West, PS – Lamphel. That, due to the communal clash that broke out from 3rd May, 2023, we had abandoned our government quarter for our safety and get evacuated to a safer place.

However, on last week of June, 2023, we had received information from our neighbours that my residential Quarter was broke opened and all my properties including my 2-wheeler Scooty Pleasure bearing registration No.MN01AE3725, were looted/stolen away by unknown miscreants on 27th June, 2023 at around 4:00 p.m.

It is, therefore, requested to kindly take up necessary legal action against the unknown miscreants and help recover my stolen properties.

Cause of delay in reporting on time is due to my displacement.
