Subject: Report regarding looting of properties from my government quarter by unknown miscreants.

Sir,

With due respect, I would like to request your kind authority for taking necessary action regarding the above mentioned subject.

That, I, Lalbiakmuang, aged 35 years D/o (L) H.Thanghulian, working as Bank Manager of Punjab & Sind Bank, Laipham Siphai Branch, at the time of incident, belonging to Paite Tribe, a Scheduled Tribe under the Constitution of India, by virtue of which I am being entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989.

That, I would like to inform and register a cognizable offence committed against me and my family at the Government allotted quarter Type IV, CP No. 42, Lamphelpat, Imphal West, PS – Lamphel. That, due to the communal clash that broke out from 3<sup>rd</sup> May, 2023, we had abandoned our government quarter for our safety and get evacuated to a safer place.

However, on 3<sup>rd</sup> June, 2023, we had received information from our neighbours that on the same day at around 8:00 a.m, my residential Quarter was broke opened by unknown miscreants and all my household properties (mentioned below) were looted/stolen away by the said miscreants.

It is, therefore, requested to kindly take up necessary legal action against the unknown miscreants and help recover my stolen properties.

Cause of delay in reporting on time is due to my displacement and ignorance of law.

List of stolen properties are as below:

1. Furniture set (Bed, Mattress, Dining Table, Dressing table, etc.) worth Rs. 3,50,000/-.
  2. Tread Mill worth Rs. 1,50,000/-.
  3. Electronic Gadgets (TV, Fan, Fridge, Washing Machine, AC, Micro-Oven, Geyser, Computer Set, etc.) worth Rs. 3,00,000/-.
  4. Sofa Set (2 sets) worth Rs. 1,80,000/-.
  5. Big Wardrobe worth Rs. 1,00,000/-.
  6. Godrej Almirah worth Rs. 2,40,000/-.
  7. Clothing and other wearing apparels worth Rs. 7 Lakhs.
