I am to bring your kind notice, that i am a Scheduled Tribe (Kuki-Zo) and an occupant of PHWD Quarter, Zone - II, National Game Village, Imphal, Manipur.

That, on the 4th May, 2023 at around 9:30 pm my above said Quarter was attacked, destroyed and looted every valuable property from my Quarter worth around Rs. 7,00,000/- (approx) by a group of Meitei/Meetei radicals.

That, while carrying out their above said criminal activities, the said Meitei readical groups were shouthing anti-tribal slogans like "HAO HATLO" "KUKI HATLO" "KANGLEIPAK YAIPHARE" etc. Hence, the same can be taken as an insult on me and my family for being a Tribal.

I, therefore, request you to kindly take strong action against the perpetrators by registering an ZERO FIR under relevant sections of the statutes of our country.
