Subject: Submission of FIR

Sir.

I, the undersigned would like to state the following facts for necessary action.

That following the 3rd and 4th May incident where unknown miscreants belonging to Meitei community numbering over thousands of people suspected to be members of Arambai Tengol, Meitei Leepun and other had ransacked, looted properties and burned residential houses belonging to KukiZo community at Langol and elsewhere Imphal, a second wave of such violence had once again took place on 13 August 2023 and there my house(its first floor with all the properties in it) at Phaipijang, Langol situated north of NIT fencing was totally burnt down and later looted the remaining properties which were at the ground floor of the building not burnt. This was reported to me over phone by one neighbour who is there with photograph. Details of properties loss are as below:

Residential building 25 x 40 size with 2 floors (Rs.40 Lakh), plot 4.13 point (Rs.9 Lakh) wooden beds 3 nos(Rs. 60K)Dulop mattress 5 nos. (Rs.1.15 lakh) Sofa set (Rs. 45K) Refrigerator (Rs. 32K) Washing machine (Rs.16K) Wooden almirah 3 nos. (Rs.75K) Steel almirah(Rs.42K) Britz Monolta colour printer (Rs.1.8 lakh) Sintex tanks 4 nos. (Rs.40K) T.V. set (Rs. 35K) Dining set (Rs. 45K) Kitchen utensil (Rs.50K) Fans & geyzer (Rs. 83K) Blankets &clothings(R 1.2 Lakh).

Total properties loss is estimated to be about Rs. 57,93,000 (Fifty seven lakhs ninety three thousand) approximately.

That I could not report the incident to my concerned police station as we were on the run and no longer has access to Imphal.

Therefore I request you to take necessary action at your end. I shall remain grateful to you.
