Sir,

With reference to the above cited subject I have the honour to report to you as follows :

1. That I **T Shemkhopao Haokip** aged about 35 years S/o (L) **Onkhogin Haokip** Belonging to the Any-Kuki Tribe / Community, a schedule Tribe recognized under the constitution of India , by virtue of which I am being entitled to the protection under **The SC/ST (Prevention of Atrocities) Act, 1989**, and that I am a Resident of **Quarter No B/20 Type II Langol Housing Complex Imphal-West District Manipur. P.O. &P.S., Lamphel.**
2. That at about 8 am on the 4<sup>th</sup> May 2023, due to the ethnic violence in the state I and my Family have to run for our lives leaving behind our Quarter, along with all our belongings. and in the process ,some unknown miscreants have looted our Quarter including all our household items and all our Original Documents.
3. That, it may be reported here that the above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated to be **Rs.15,00,000 ( Rupees Fifteen Lakhs) only**
4. Fortunately, I managed to escape from the Violence, and now currently taking refuge at **district Headquarter Tuibong Churachandpur .**
5. That, I am filing this information lately because there is a great danger to my life and due to which I was at different places to save my life and now I am able to restore my health and settled at The above mentioned address. And thus, I am filing the report lately today.

In the given circumstances, I humbly pray you kindly register an FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And , for which act of kindness, I shall always remain thankful to you and obliged.
