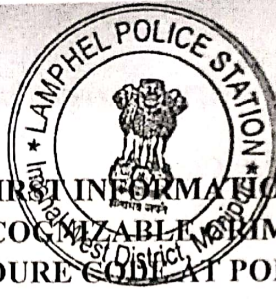

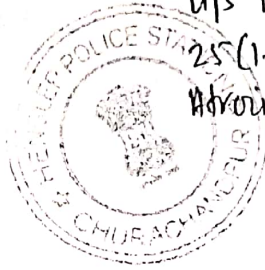

With reference to the above cited subject, I have the honor to report to you as below:

1. That, I Lunkhomang Haokip age 31 S/o Helkhochon Haokip belongs to KUKI Community, a Schedule Tribe recognized under the Constitution of India. By which I am entitled for protection under the ST/SC (Prevention of Atrocities) Act 1989. Whereby, I had stayed at rent at National game Village, P.S Lamphel, District Imphal west.

2. That on, 3rd may 2023 at 10pm huge contingent of Armed Radical Meitei/Meiteis, Arambai Tenggol and Meitei Leepun attack our village, and in the process burnt/looted/vandalized my rented properties.

3. That, the above said Criminals with their inhuman activities have caused me grave mental agony. Notwithstanding the fact that, their unruly activities have made me loss enormous wealth estimated to be Rs.31.80 Lakhs only.

4. Fortunately me and my family narrowly escaped from these criminals who even tried to killed us. Henceforth, we are taking refuge at Immanuel ECA Church relief Centre B. Venghnom, Churachandpur.

I, Therefore, request you to register FIR and bring justice.
