With reference to the above cited subject, I have the honour to report to you as follows:

That, due to the prevailing ethnic crisis in and around Imphal, I along with my family left our permanent resident at Langol, Laimanai, Paite Colony, District- Imphal West on the 4th of May, 2023 at around 9.30 AM, took refuge at Central Reserve Police Force (CRPF) camp, Lamphel where I left my Vehicle at the front gate of Kendriya Vidyalaya School, **P.O. & P.S.-Lamphelpat**, district-Imphal West-795004. And, with the help of a good friend belonging to different community, it has come to our knowledge that the deserted vehicle is missing from the said location when checked on the 5th of May, 2023 at around 5:30 AM. That, I do not know, nor suspect anybody to be the perpetrators behind the said missing vehicle till date.

That, the said **Insured vehicle** is worth about **Rs.9,00,000/- (Rupees Nine Lakhs)** Only.

That, I am filing this information lately because there is a great danger to my life and due to which I was at different places to save my life and now I am able to restore my health and I humbly pray you to kindly register a **ZERO FIR**, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged. Thus, I am filing the report lately today
