Subject :- Report on Looting household items/assets, and discrimination of Schedule Tribes.

Sir,

With reference to the above cited subject I have the honour to report to you as follows :

1. That I **Steffy Haokip** aged about 34 years W/o **Paokhogin Haokip** Belonging to the **Any-Kuki Tribe / Community**, a schedule Tribe recognized under the constitution of India , by virtue of which I am being entitled to the protection under **The SC/ST (Prevention of Atrocities) Act, 1989**, and that I am a Resident of **Qtr.No. T-B/152, NGV National Game Village Imphal-West District Manipur. P.O. & P.S., Lamphel.**
2. That at about 8 am on the 4th May 2023, due to the ethnic violence in the state I and my Family have to run for our lives leaving behind our house, along with all our belongings. and in the process ,some **unknown miscreants** have looted our house including all our household items and Documents.
3. That, it may be reported here that the above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated to be **Rs.12,00,000 (Rupees Twelve Lakhs) only**
4. Fortunately, I managed to escape from the Violence, and now currently taking refuge at **Zenhang Lamka Churachandpur Manipur.**
5. That, I am filing this information lately because there is a great danger to my life and due to which I was at different places to save my life and now I am able to restore my health and settled at The above mentioned address. And thus, I am filing the report lately today.

In the given circumstances, I humbly pray you kindly register an FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And , for which act of kindness, I shall always remain thankful to you and obliged.
