Subject :- Report on Crimes of Looting, Vandalism of Properties and Discrimination of Schedule Tribes.

Sir.

With reference to the above cited subject I have the honour to report to you as follows:

- 1. That I Benny Vanlalruotsang aged about 38 years S/o R.C. Daniel Belonging to the Hmar Tribe / Community, a schedule Tribe recognized under the constitution of India, by virtue of which I am being entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989, and that I am a resident of Quarter No. 9, Type III/C Lamphel, Imphal West Manipur P.O & P.S., Lamphel.
- 2. That, due to the ethnic violence in the State at about 2:30 pm on the 4th of may, 2023, a huge contingent of armed radical meeitei/Meitei suspected to be members of the Arambai Tenggol and Meetei Leepun along with Meitei locals in and around the area attacked all the Kuki-Zo Community in the Imphal Valley. The mob shouted slogans like "Kuki Hatlo' meaning Kill the kuki, 'Hao Hatlo' So, I and my family have to run for our lives in order to save ourself from the angry mob and took shelter in the nearby C.R.P.F Camp. And in the process, they have looted and vandalized my Quarter along with all our household items.
- 3. That, it may be reported here that the above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated to be Rs. 20,00,000/- (RupeesTwenty Lakhs) only.
- 4. Fortunately, me and my family managed to escaped from the criminals who even tried to kill us, and now currently taking refuge at Sielmat Village Churachandpur.
- 5. That, I am filing this information lately because there is a great danger to my life and due to which I was at different places to save my life, and now I am able to restore my health and settled at the above mentioned address .And thus, I am filing the report lately today.

In the given circumstances, I humbly pray you kindly register an FIR/ZERO FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged.
