Subject :- Report on Looting, Vandalism and burning down of house, household items/assets and
Discrimination of Schedule Tribe.

Sir,

With reference to the above cited subject I have the honour to report to you as follows :

1. That I Letkhohen Khongsai, aged about 65 years H/o Chinkhonem Khongsai Belonging to the Any-Kuki Tribe / Community, a schedule Tribe recognized under the constitution of India, by virtue of which I am being entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989, and that I am a Permanent Resident of Khongsai veng laipham khonou Imphal-East, P.O., Lamlong, PS., Perompat, Lamphel.
2. That at about 1:30 pm on the 4th May, 2023, a huge contingent of armed radical Meeitei/Meitei suspected to be members of the Arambai Tengol and Meetei Leepun and a mob attacked our Locality at the above mentioned address. So, in order to save our lives, we left behind our house with all our belongings including My four wheeler MAHINDRA BOLERO ZLX (White Colour) Bearing Reg. No.MN06LA8161, Chassis No. MA1XX2GRKF5D45640, Engine No. GRF4C82658 and Two Wheeler DESTINI 125(VX) (Chesnut Brown), Reg.No.MN06SF7988, Chassis No. MBLJFW059KGL01782 , Engine No. JF17EJKGK03618.in the process they have looted Vandalised then then burnt down our house including all our belongings along with my Four Wheeler as well as my two wheeler.
3. That, it may be reported here that the above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated to be Rs. 1,04,00,000 (Rupees One Crore Four Lakhs) only
4. Fortunately, I managed to escaped from the criminals who even tried to kill us, and now currently taking refuge at Gamnomjang Village Tuibong, Churachandpur .
5. That, I am filing this information lately because there is a great danger to my life and due to which I was at different places to save my life and now I am able to restore my health and settled at the above mentioned address. And thus, I am filing the report lately today.

In the given circumstances, I humbly pray you kindly register an FIR/ZERO FIR , investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And , for which act of kindness, I shall always remain thankful to you and obliged.
