Sir.

With reference to the above cited subject, I have the honour to report to you as follows:

- That, I Smt. Grace N Tonsing aged about 56 years, belonging to the Paite Tribe/Community, a Scheduled Tribe recognized under the Constitution of India, by virtue of which I am being entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989.
- That, I Smt. Grace N Tonsing, working as Asst. Private Secretary at PWD Khoyathong, Imphal West is an allottee of government residential quarter No. 54 Type – II/A situated at Lamphelpat, Imphal West P.O & P.S Lamphel.
- That on the 3rd of May, 2023 due to the ongoing ethnic cleansing drive against the minority of the state spearheaded by the majority Meitei/Meetei Community. For fear of our lives and safety, me and my family took shelter at Lamphel CRPF Camp on the 4th of May 2023 and thereafter fled the state and have taken shelter at a relatives place.
- That, after I deserted my residential quarter mentioned here in above for the sake of our lives and security, it came to my knowledge that our house has been vandalized and looted by a group of unknown Meitei Miscreants on the 01/06/2023 at around 10:00am and then again on 05/07/2023 at around 8:00am . These people broke inside our property, then vandalized and looted all what is within my quarter comprising of all my household items/assets along with all of my gold and silver jewellery which was locked inside the cupboards and my vehicles comprising of a car and a vespa scooty, which are all lost due to the said incident. A total lost estimated to be at an amount of Rs 30,00,000/- (Rupees Thirty Lakhs) Only was all lost.

In the given circumstances, I humbly pray you to kindly register an FIR, and investigate into the matter and punish the perpetrators as per the prevailing provisions/laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged.
