That I am a Scheduled Tribe belonging to the *Hmar Tribes*, a recognized Scheduled Tribe under the Constitution of India. And, we rented a house located at *Langol, PO & PS – Lamphelpat*, Imphal West, Manipur.

That, due to the prevailing ethnic crisis in and around Imphal Valley, our family deserted our above mentioned resident on the 4^{th} May, 2023 at about 6:30 pm, we took refuge at CRPF Camp, Lamphel. And, on the 27^{th} of July, 2023 at around 9:30 pm, a group of armed Meitei/Meetei suspected to be members of Arambai Tenggol and Meitei Leepun looted and vandalized our properties.

That, it may also be reported here that the above said criminal activities have caused mental agony and incurred huge loss which may be estimated to be *Rs.95,0000 /- (Nine lakhs Fifty Thousand)* only.
