With due respect, I the undersigned would like to make a report to your good office about looting of properties and burning down of properties from the rented quarter of RIMS Quarter No-III N0-33, Lamphel, P.O & P.S- Lamphel & District-Imphal West, 795004 on 04-05-2023 at 2:30 pm by mob (Meltei/Meetei) along with suspected members of the Arambal Tengol and Meeitei Leepun.

At the very outset, I would like to draw fewline for your information that due to the present situation of ethnic class between Tribal and Valley base Meitei/Meeite from 03-05-2023. On 04-05-2023 at 2:30 pm the lock of my quarter was destroyed by mob (Meitei/Meetei) along with suspected members of the Arambai Tengol and Meeitei Leepun, they looted my properties and burnt down some of my properties which worth Rs.15,60,000/-(Rupees Fifty Lakh Sixty Thousand) only on the said day. I along with my other family member have to flew out from our resident for our life because Unknown Meeitei/Meitei's goons tried to kill us for being a schedule tribe and pointing us that we are a Kuki tribe a tribal.

It is requested to your good office to make entry of my report a Zero F.I.R and take action against the perpetrator as per Law and also issue me the copy of the said report for my reference in future. I could not make the said report on time as I could not reach my native place on time after running out from Imphal City for saving my life and family life.
