

Subject: Report on crimes of looting & vandalism of a *Variety Store* and discrimination of Scheduled Tribes.

With references to the above cited subject, I have the honour to report to you as follows;

I am a scheduled tribe belonging to the *Paite Tribe*, which is a recognized tribe under the Constitution of India and a permanent resident of Zion Veng, New Lamka, P.O., P.S. & District-Churachandpur, Manipur.

That, with the help of a good friend belonging to a different community / tribe, it came to my knowledge that, on the 27<sup>th</sup> of August, 2023 at around 4:30 PM, a mob of Meetei/ Meitei suspected to be members of Arambai Tengool, Meitei Leepun along with the Meetei/Meitei miscreants attacked my shop, in the process they have looted and vandalized my Variety Shop located at *Paite Veng, Sangaiprou, P.O. & P.S.- Lamphelpat, District-Imphal West, Manipur*.

That, the said Variety Shop which is Registered in the name & style of '*M/s Muamuan Tonsing Variety Store*' under the name of Tuankhanmang bearing Regn. No. IW/1220(S) of 2019 is registered on the 14<sup>th</sup> of August, 2019 under *The Office of Registering Officer under the Manipur Shops and Establishment Act, 1972*.

That, it may also be report that the said criminal activities have cause grave mental agony and incurred huge lose which is estimated to be about Rs. 10,70,000 (*Rupees Ten Lakhs Lakhs Seventy Thousand*) Only.

That, the reason behind my late application is due to which I was just informed about the criminal activities lately. Therefore, I humbly pray you to kindly register a ZERO FIR, and book the perpetrators under the relevant laws of our Country. And for which act of kindness I shall always remain grateful to you. Thus, I am filing this application lately today.
