That, with the help of a good friend belonging to a different community / tribe, it came to my knowledge that, on the 27th of August, 2023 at around 4:30 PM, a mob of Meetei/ Meitei suspected to be members of Arambai Tengool, Meitei Leepun along with the Meetei/Meitei miscreants attacked my shop, in the process they have looted and vandalized my Variety Shop located at Paite Veng, Sangaiprou, P.O. & P.S.- Lamphelpat, District-Imphal West, Manipur.

That, the said Variety Shop which is Registered in the name & style of 'M/s Muamuan Tonsing Variety Store' under the name of Tuankhanmang bearing Regn. No. IW/1220(S) of 2019 is registered on the 14th of August, 2019 under The Office of Registering Officer under the Manipur Shops and Establishment Act, 1972.

That, it may also be report that the said criminal activities have cause grave mental agony and incurred huge lose which is estimated to be about Rs. 10,70,000 (Rupees Ten Lakhs Lakhs Seventy Thousand) Only.

That, the reason behind my late application is due to which I was just informed about the criminal activities lately. Therefore, I humbly pray you to kindly register a ZERO FIR, and book the perpetrators under the relevant laws of our Country. And for which act of kindness I shall always remain grateful to you. Thus, I am filing this application lately today.
