Subject:- Report of vehicle theft & looting of Government Quarter.

Sir,

I am to state that me and my family have been forced to leave my Government allotted residence located at G/III-64, Langol Housing Complex, Imphal, Manipur on 4th May, 2023 due to the ongoing communal conflict.

My residence have been looted and stolen away our vehicle i.e., (i) Maruti Suzuki Celerio ZXI, Colour (Glistening Grey), Body type: Rigid (Passenger Car), Registration No. MN01AW-1318, Chassis No. MA3TFC62SNE157174, Engine Motor No. K10CN1020184, Date of Registration-2nd July, 2022 valid up to 1st July, 2037 (Registration in my name) and (ii) TVS Jupiter (T-Grey Colour), Registration No. MN01AF-1347, Engine No. EG4GJ1418621, Chassis No. MD626EG41J3G89295, Date of Registration-16th November, 2018 (Registered in my husband's name) which were left behind at our residence had been taken away along with all my household stuffs on 30th October, 2023 at around 02:00 PM by unknown miscreant(s). My properties, household stuffs etc., worth Rs.40 Lakhs (approx) had been looted, destroyed and stolen away by unknown miscreants(s).

I request you to acknowledge that the above-stated vehicles are no longer in my custody and control so I cannot be held liable for any misuse of the vehicles.

Also, I could not make this complaint report well in time, as me and my family were fleeing to Delhi for the safety of our lives since 4th May, 2023.

I, therefore, request you to kindly look into the matter and take necessary action at your end.
