Sir.

I, the undesigned, am the sister of Mr. Francis Khupthanlian who is currently working as a Tax Assistant at GST, Aizawl Commisionerate and we belong to the Paite Tribe, a recognized Schedule Tribe of India. My said brother previously worked in the Income Tax Department in the Office of the Assistant Commissioner of Custom Division, Imphal and was alotted CPWD Qtr. $Type-B/08\ (FF)\ located\ at\ GPRA\ Colony,\ Sangaipou,\ Imphal\ (Copy\ attached).\ However,\ on\ 3^{rd}$ May, 2023 when the ethnic clash between the Meitei and Kuki-Zomi broke out, as Paite Veng in Sangaiprou happens to be one of the first targeted place in Imphal, there was manhunt for Kuki-Zomi Tribals by the Meitei Radical groups which compelled my said brother and his family to fled for their life leaving all their belongings locked in the said quarter. Thereafter, as there is no chance of survival on returning back to Imphal Valley, my said brother reported and joined in his present place of Posting at GST, Aizawl Commissionerate, Khatla, Aizawl and remains so till date.

Upon my said brothers application dated 23-08-2023 for vacation of his quarter (Copy attached), the Junior Engineer, CPWD Quarter, Mr. Nitesh Kumar Sharma went to check out the quarter on 26/08/2023 at @ 1:09 it came to our knowledge that my said brother's official quarter was robbed and looted by unknown valley miscreants, and all materials inside like 2 set of sofa, 3 set of table, Television, Fridge, Washing machine, all Kitchen goods, 4 nos. of mattresses, all their household good etc estimated to be at a value of about 9-10 lakhs only were missing and the said quarter is left empty with only one Queen-size bed. Further, as my said brother is currently in Aizawl, and being down with Conjunctivitis, I report this matter on his behalf in the earliest

I, therefore, would like to request your office to take necessary action as per law at the earliest for the end of justice.
