Subject :- Report on crimes of looting, vandalism, unlawful displacement, criminal intimidation and discrimination of scheduled tribes.

Madam,

With reference to the above cited subject I have the honour to report to you as follows :

1. That I **Thangjangam Mate** aged about 20 years S/o **Jangkholet Mate** Belonging to the **Mate Tribe / Community**, a schedule Tribe recognized under the constitution of India , by virtue of which I am being entitled to the protection under **The SC/ST (Prevention of Atrocities) Act, 1989**, and that I am a resident of **Khongsai Veng Imphal-East P.O & P.S., Lamphel - 795001**
2. That at about 3:30 pm on the 4th of may 2023, a huge contingent of armed radical meetei/Meitei suspected to be members of the Arambai Tengol and Meetei Leepun along with Meitei Mob attacked our locality, so I and my younger sister have to run for our lives and took shelter at 2nd MR (Manipur Rifles) leaving behind our rented house owned by **Mr Otkhopao Khongsai**. And in the process, they have looted and vandalized my house along with all my Documents and household items.
3. That, it may be reported here that the above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated to be **Rs. 10,00,000 (Rupees Ten Lakhs) only**.
4. Fortunately, me and my family managed to escaped from the criminals who even tried to kill us, and now currently taking refuge at Songza **Khopi Tuibong Village** Churachandpur.
5. That, I am filing this information lately because there is a great danger to my life and due to which I was at different places to save my life and now I am able to restore my health and settled at the above mentioned address. And ,thus I am filing the report lately today.

In the given circumstances, I humbly pray you kindly register an **FIR/ZERO FIR** , investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And , for which act of kindness, I shall always remain thankful to you and obliged.
