
Sir,

I have the honour to state that, On 04-05-2023 at around 11:45 pm some unknown miscreants suspected to be a members of Meitei Youth Organisations, Meetei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) carrying dangerous weapon forcefully entered our locality at Police MT Quarter, Lamphel Imphal west about 45 km South from Saikul-PS. They vandalised my Quarter house after looting all the moveable properties, Furnitures, Jewellery, Utensils, Kitchen Wares, Electronic items, Books including one two wheeler Activa (6G) bearing regd. No. MN06S 116703 and one car i20 grey colour, leaving us homeless.

The approximate value of lost property is calculated at about Rs.31,00,000/- (Thirtyone lakhs)


It is, therefore, requested you to kindly registered a regular case and take necessary legal action against the culprits according to law.
