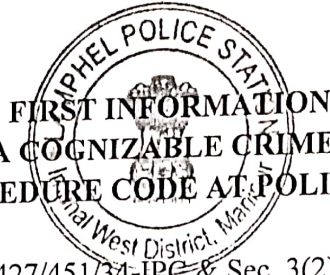

Sir,

I the undersigned have the honour to report some few lines for your kind and sympathetic action:

2. That, I S. Teresa Nemneithem Baite, aged 35, residing at Langgol Housing Complex Type-III, H-2 and working as Tutor, College of Nursing, Lamphelpat belong to Kuki community, a Scheduled Tribe under the constitution of India by which I am entitled for protection under the ST/SC (Prevention of Atrocities) Act, 1989.

3. That, on 14<sup>th</sup> July, 2023 around 3:30 pm, some unknown miscreants looted/vandalised all my property.

4. That, I could not make the said report on time as I was on study leave vide Secretariat: Health Department Order No. MED-4016/5/2021-HS-HEALTH dated 31<sup>st</sup> October, 2023 (copy enclosed).

So, I therefore request you to kindly look into the matter and register an FIR so as to enable me to get justice.

A copy of statement showing value of properties looted and damaged by the miscreants amounting to Rs. 17,23,000/- (Seventeen Lakhs Twenty Three Thousand only) is attached as Annexure.
