I am a scheduled tribe belonging to the Paite Tribe, which is a recognized tribe under the Constitution of India and a permanent resident of Emmanuel Colony, Langol Laimanai, Meitel Langol, P.O. & P.S.- Lamphelpat & District- Imphal West, Manipur-795004.

That, on the 24<sup>th</sup> of June, 2023 at around 10:30 AM, and with the help of a good friend belonging to another Tribe/Community, it came to my knowledge that a group of Meitei / Meitei criminals . came with vehicle, broke open the door of my house and in the process, they have vandalized the in-build assests of my house, looting and destroying the properties, along with all the Original Certificates, that includes;

Original Certificates:

All Educational Certificates & Service Documents of High Court of Manipur belonging to Ms. Florence Zenmuankim, aged about 47 years, D/o (L) Vumzathang Guite.

That, it may also be report that the said criminal activities have cause grave mental agony and incurred huge lose which is estimated to be about Rs. 1,34,51,700/- (Rupees One Crore Thirty-Four Lakhs Fifty-One Thousand Seven Hundred) only, including all the household/ movable assest and the estimated value of the said vandalized house.

That, I am filing this application lately as I was on different remote areas for months.

That, I humbly pray you to kindly register a ZERO FIR, and booked the perpetrators under the relevant laws of our Country. And for which act of kindness I shall always remain grateful to you. Thus, I am filing this application lately today.
