I am permanent resident of Games Village, PS Lamphel, Imphal West District.

In that, my Residential Quarter No. B/287, Zone-1, National Game Village, Imphal West District, was attacked by Meitei miscreants suspected to be personnel of Arambai Tengol and Meitei Lepun along with local people at around 3.00 pm of 7/5/2023. In the process, the said miscreants vandalized and looted all my properties. The list of properties looted/damaged are as below-
