That, with the help of a good friend belonging to a different community, it has come to my knowledge that, on the 28th of Nov., 2023 at around 5:30 PM, a mob of armed Meetei/ Meitei suspected to be members of Arambai Tengool, Meitei Leepun along with the local people of the areas attacked our village, targeting the minorities Tribal Kuki-Zo's and in the process they have looted all my belongings/ movable assets which we deserted at the above mentioned location.

· That, it may also be report that the said criminal activities have cause grave mental agony and incurred huge lose which is estimated to be about Rs.8,50,000 (Rupees Eight Lakhs Fifty Thousand) Only, that's inclusive of my household items alone.

Therefore, I humbly pray you to kindly register a ZERO FIR, and book the perpetrators under the relevant laws of our Country. And for which act of kindness I shall always remain grateful to you. Thus, I am filing this application today.
