With references to the above cited subject, I have the honour to report to you as follows;

I am a scheduled tribe belonging to the *Simte Tribe*, which is a recognized tribe under the Constitution of India and a resident of Qtr. No.- B/376, Zone I, National Games Village, P.O. & P.S.- Lamphelpat, district- Imphal West, Manipur.

That, with the help of a good friend belonging to a different community, it has come to my knowledge that, on the 28th of Nov., 2023 at around 5:30 PM, a mob of armed Meitei/Meitei suspected to be members of Arambai Tengool, Meitei Leepun along with the local people of the areas attacked our village, targeting the minorities Tribal Kuki-Zo's and in the process they have looted all my belongings/ movable assets which we deserted at the above mentioned location.

• That, it may also be report that the said criminal activities have cause grave mental agony and incurred huge lose which is estimated to be about **Rs.8,50,000 (Rupees Eight Lakhs Fifty Thousand)** Only, that's inclusive of my household items alone.

Therefore, I humbly pray you to kindly register a ZERO FIR, and book the perpetrators under the relevant laws of our Country. And for which act of kindness I shall always remain grateful to you. Thus, I am filing this application today.
