Subject: Report.

Respected Sir,

I have the honour to state that I am a scheduled tribe belonging to the Tangkhul Tribe, which is a recognized tribe under the Constitution of India and a permanent resident of Lamphel PHED, , P.O. & P.S.- Lamphel & District- Imphal West, Manipur-795004.

On the fateful day i.e. 12/12/2023 in between 12:30 pm to 4:30 pm, 8 unknown miscreants comprising of 5 male and 3 female came to the shop, I am working, namely "Style Salon & Spa" at Chingmeirong near Vishal Mega Mart, Imphal. Suddenly, they took out pistols and forcibly took all the mobile handsets of the staffs and made us move out of the shop and boarded all the 6 staffs on a Maruti Gypsy and Maruti Car whose registration number could not be remembered. The unknown miscreants took us unknown place (suspected to be Sekta) towards Lamlai side for enquiring us.

In the meantime, Thangjam Sanathoi, the owner of the shop came to the unknown place on being called by the unknown miscreants. The unknown miscreants started beating me and the owner, Sanathoi, badly and also threatened both of us to shoot on our legs or kill us. Further the unknown miscreants threatened all the staffs not to work on the said Salon and if denied will kill us.

Later, the unknown miscreants demanded Rs. 5,00,000/- (Rupees Five Lakhs) to the owner of the Salon. The unknown miscreants capture the photo and also took the Aadhaar Card of the owner. After that they dropped us at Sangakpam.

It is therefore requested to kindly take up legal action against the culprits and book them as per provision of law.
