Most respectfully, I am writing this complaint report to bring to your attention a serious incident that occurred on 16-12-2023 in between 4:30 pm to 5:00 pm, involving the kidnapping and robbery of my car. I kindly request your immediate assistance in this matter.

That, on the mentioned date, while I was parking my car near Tangkhul Avenue Leirak and waiting for my father, a white Brezza without a number plate approached me. To my surprise, five unknown individuals emerged from the vehicle and approached me. They demanded to know my identity and proceeded to check the Registration Certificate (RC) of my car, which my elder brother namely Hillson Rungsung purchased from one Paojamin Guite of Pashong village, Ukhrul District.

I would like to mention that my brother bought this car in 2022, but the sale deed was executed on 28/10/2023. Due to the ongoing violence in the region, he has been unable to complete the process of changing the name on the registration certificate. That, I was instructed to drive my car towards Lairikyengpam Leikai. However, upon reaching there, they forcibly took possession of my car and provided me with a contact No.:- 9362002807. Despite numerous attempts, they have not returned my car.

In light of these distressing events, I kindly request you to register a FIR regarding the incident and provide your full support and assistance in locating and recovering my car.

Thank you for your attention to this matter. I shall be ever grateful for your kind action.
