With due respect, I have the honour to state that on 3<sup>rd</sup> and 4<sup>th</sup> May, 2023 at around 7:30 pm unknown suspected to be Arambai Tenggol, Meeitei Leepun, Iroisemba Meeitei more than 200/300 peoples from the Meeitei community attacked my resident Quarter No. D/116 Zone-I National Game Village, Imphal West District, Manipur destroyed everything and looted all my properties and left my quarter empty.
