After looting all the immovable and movable properties, they vandalised and destroyed my house. The approximate value of properties destroyed estimate calculate at about Rs.59,20,000/- (Rupees fifty nine Lakhs and twenty thousand).

So, I therefore requested you to kindly register this case and take the necessary legal action against the culprits according to the law.
