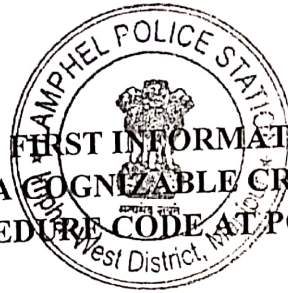

Sir,

I have the honour to state, on date 04/05/2023 at around 11:00 AM some unidentified groups suspected to be the members of Meitei Organisation such as Meitei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tengol about 1500-2000 people, carrying sophisticated weapons forcefully entered our village i.e Phaipijang, Langol Housing Complex, House number 55, PO Lamphel PS Lamphel, Imphal West district, Manipur.

After looting all the immovable and movable properties, they vandalised and destroyed my house. The approximate value of properties destroyed estimate calculate at about Rs.59,20,000/- (Rupees fifty nine Lakhs and twenty thousand).

So, I therefore requested you to kindly register this case and take the necessary legal action against the culprits according to the law.
