**Subject: Report on destruction and burning of Fencing and Godown at  
Khongsai Veng (Laipham Khunou), Imphal, Manipur.**

Sir,

I have to report that on 4<sup>th</sup> May, 2023 at around 5:00pm, some miscreants, suspected to be some Meitei radicals, attacked Khongsai Veng at Laipham Khonou, Imphal and burnt down many houses. As I could not personally visit the locality due to ethnic problem, I was not able to confirm the status of my properties at the said locality, I could not file any complaint during that period. Now, through some sourcemen, I could confirm that the pucca fencing at my plot was totally dismantled, and my Godown inside the fencing, including all building materials and accessories, were also burnt down completely. My Patta No. is 260(Old) or 346/1805 (New) under 011-Laipham Siphai, Heingang Tehsil, Porompat Sub-Division, Imphal East District, Manipur.
